Personally appeared before me the affiant Sarah A Williamson who being duly sworn deposes and says that defendant Jamison Antwan Jones did within this county and state on or about 12/8/2024 violate the criminal laws of the State of South Carolina (or ordinance of [X] County/ [] Municipality of Dillon) in the following particulars:

DESCRIPTION OF OFFENSE: Abuse / To inflict great bodily injury upon a child

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or about December 08, 2024 Jamison Antwan Jones, within the jurisdictional boundaries of Dillon County, committed the crime of abuse /to inflict great bodily injury upon a child. The victim, two month old [Redacted] sustained injuries including several fractures, a subdural hematoma, a torn upper frenulum, and retinal hemorrhaging, as indicated by medical staff and records at [Redacted] of South Carolina Charleston, all while in the sole care of the defendant. The defendant's actions, therefore, caused the victim to be at substantial risk of death. The defendant was [Redacted]
